CALL MEETING TO ORDER

Mayor Oscovitch called the meeting to order at 7:00 p.m.

CALL COUNCIL MEETING BACK TO ORDER

FLAG SALUTE AND MOMENT OF SILENCE

APPROVAL OF AGENDA – Motion by Councilman Olson second by Councilwoman Kash, to approve the agenda. All members were in favor. Motion carried.

DISCUSSION ITEMS

Special Presentation – Health Benefits Consultant – Frank Covelli

Mr. Sabatini explained that Health Insurance is the second largest line item in the budget. Byram Township is a member of the North Jersey Health Insurance Fund (NJHIF), Byram Township has 31 active employees that are eligible for health benefits, and 26 retirees, of the 31 active employees 9 waive the health benefits, and the 26 retirees that receive health care benefits, must continue to receive benefits that are equal to or better than what they received when they retired. Only one out of 26 retirees contribute to the cost of health care.

Mr. Covelli gave an informative presentation about the current health insurance benefits received by Byram Township employees and retirees. He went into detail about the NJHIF (North Jersey Health Insurance Fund) that is made up of 28 other municipalities and how the fund works. He also explained the differences between the Health Benefits obtained through the NJHIF versus the NJ State Health Benefits program and other conventional insurance companies.

Motion by Councilman Olson, second by Councilwoman Raffay to open to the public for discussion. All members in favor. Motion carried.

Joanne Smith, 57 Lake Drive, Ms. Smith asked for clarification as to why Byram Township cannot go into the State Health Benefits Plan. Joe explained that the retiree's liability obligation of what it would cost to supplement claims and make the retirees whole is the reason. Byram Township could lose money if it moved to State Health Benefits. Mr. Sabatini explained that you cannot negotiate with a retiree. Their contract is what they had on the day of their retirement. Ms. Smith asked how much the Township pays for a family plan. Mr. Gray said that it could cost \$40,000.00 for the Patriot 5. Ms. Smith asked Mr. Covelli if he receives a commission from the Township. Mr. Sabatini said that Mr. Covelli receives a flat rate of \$3,000.

Alex Rubenstein, 3 Partridge Road, Mr. Rubenstein asked what the differences are in the benefits that the current retirees have received vs. the employees that have yet to retire and will they also receive the same plans. Mr. Sabatini explained that the police retirees have access to the richest plan which is the Open Access Plan, the others have access to the Patriot 5, any new hires have access to lower cost options. DPW, Administrative, and Clerical Employees that are hired after 2010 are not eligible for health care benefits upon retirement. Mr. Rubenstein asked if the groups can be split and separate out the retirees from the actives. Mr. Covelli explained why this cannot be done because of policies set by the State Health Benefits. Mr. Rubenstein asked what it would cost to make retirees whole. Mr. Sabatini explained that the Township could lose about \$20,000 per year if he were to make them whole. Mr. Rubenstein asked if the claims experience was public information. Mr. Covelli explained that only the sum on all fees paid is public information.

Motion by Mayor Oscovitch to close to the public, second by Councilman Olson. All members in favor. Motion carried.

Municipal Building – Next Steps

Mr. Sabatini looked into options for moving forward with construction of the municipal building. Some options available are to work with the National Joint Power Alliance (NJPA) which is a co-op, EI Associates which is an architectural engineering construction firm, or the possibility of renovating the open space in the Byram Intermediate School.

The Township Manager, Mayor and Council discussed the options and it was agreed upon to move forward with sending out an RFP for an architect.

TOWNSHIP MANAGER/COUNCIL REPORTS

Township Manager – Mr. Sabatini introduced Michael Orgera as the new Superintendent of Public Works. Mike has over 18 years of experience, including sewer and water treatment experience. He is a Certified Public Works Manager, a Certified Recycling Professional, and a Certified Clean Communities Coordinator. Mr. Sabatini welcomed Mr. Orgera to the Township and is looking forward to working with him.

Byram Day is on September 24th at 11:00 (Rain Date of September 25th). Information is up on the website and there was also a flier that was sent out.

Sussex County Day is September 18th, It is same day as the Champion of the Grill. They are looking for volunteers from the Township Council to attend this event.

Nisha Kash

Byram Day is scheduled for September 24th with a Rain Date of September 25th starting at 11:00am. There will be the annual Byram Day Run, Touch a Truck, inflatable rides, and a mini health fair.

Councilman Olson –

The guide rails at Mohawk Ridge have been taken down and replaced with new rails.

The Transportation Trust Fund / Roseville Road Bridge - A letter was sent to Senator Oroho and copied to the Freeholders as well. Mr. Olson gave Freeholder Graham a call, who then provided additional names of people to send it to. It should be addressed by the freeholders office within the next week, and it appears hopeful that he would be able to help. It may not be until April 2017 that work would start back up.

On September 8, 2016 the Musconetcong Watershed Association will hold a press conference / seminar which is open to the public to attend.

On September 19, 2016 Congressman Frelinghuysen will be visiting the EPA Superfund Site at 9:00am located off of Stanhope Sparta Road.

Scott would like add to an upcoming agenda on behalf of the Open Space Committee a discussion promoting the use of the trails within Byram Township as part of the Economic Stimulus.

Councilman Gray –

On September 29th at 7pm there will be a Committee Head meeting.

Councilwoman Raffay –

On September 7th, the Lenape Valley Marching Band will be holding a band competition at 6 p.m. at Lenape Valley High School.

September 15th at 8:00 p.m. is the next scheduled Planning Board Meeting. There has been discussion about making changes to the neighborhood commercial zone. They would like a formal recommendation from the Township Council. Mrs. Raffay would like to suggest authorizing Doris Flynn to write a letter to the planning board to this regard.

Mayor Oscovitch –

September 9th at 6:00pm the Lenape Valley Junior Patriots will be having their annual Pep Rally at C.O. Johnson Field.

September 12th the Lenape Valley Soccer Club is having their Opening Day.

Mayor Oscovitch followed up on the letter sent to Senator Oroho's office and he received a different response than that of Freeholder Graham's office. He was told that there is no money, and that it's not going to be opened up under an emergency situation.

Tom Collins

Tom would like to recommend adopting resolution 145-2016 at tonight's meeting, approving the settlement agreement, and that the Planning Board do the same at their meeting on September 15, 2016.

PUBLIC PARTICIPATION I

Motion by Councilman Olson, second by Councilman Gray to open to the public. All members in favor. Motion carried.

Yvonne Reeves, 80 River Road, expressed concerns about a very strong odor that she believes is coming from the Musconetcong Sewage Authority. Ms. Reeves has contacted the MSA and the EPA both to this regard. The smell is on a constant basis and is effecting the quality of life for her, her family and her neighbors.

Sanda Opel – 76 River Road – addressed the same concerns about the smell.

Barbara Kostiuk, 40 River Road, addressed her concerns on behalf of the West Brookwood Property Owners Association about the smell coming from the MSA.

Councilman Gray suggested that this issue should be brought to the attention of the Local Board of Health in an attempt to resolve the problem. If they are not able to attend the Board of Health meeting on September 27, Mr. Gray suggested that they forward him the list of dates that they complied as to when they smelled the sewage and he will bring it with him to the Board of Health meeting.

Councilman Olson suggested bringing it to the attention of the Sussex County Division of Health.

Mr. Collins suggested sending all this information to the Township Manager so he can have it addressed with the Sussex County Division of Health.

Merwin Lee, 45 Winding Way, stated that he recalls the issue with the smell occurring back in 2006. He also addressed his concerns about robo calls, and suggested that Township warn the residence of these calls on the Township website. Mr. Lee informed the Township Council that the Closed Road sign on Roseville Road has been spray painted and that the reflection is now taken away. He also asked who is responsible for trespassing on this site. He also addressed his concerns with Hudson Farm West changing the land use from farmland to commercial.

Joann Smith, 57 Lake Drive, Addressed her concerns about another bond ordinance. She stated that something needs to be done, but with less being put on the tax payers.

Luann Byrne, 34 Richmond Road, asked if the Affordable Care Act helps with the Townships Health Insurance. Mr. Sabatini said that the Township is not able to use the affordable care act at this time to provide Health Insurance.

Ms. Byrne added that she likes Councilman Olson’s idea about a steel frame or pre fabricated building as an option for the Municipal Building. Ms. Byrne did not know where Neil Gyling Park was located. She suggested putting more information on the Byram Day sign. She also is wondering what is happening with putting an interactive map on the Township website. Mr. Sabatini said that this is something that is currently being worked on.

Dawn Christian, 3 Banker Drive, thanked Joe Sabatini for looking into opportunities where the community can be involved with projects that affect the community. She is hesitant about how open the RFP is for the Municipal Building and would like to know how much space is really needed, and asked if anyone has looked at the traffic that goes through the current building. She would like the RFP to be very detailed to the use needed for office space. Councilwoman Raffay said that this was looked into a year ago during the feasibility study.

Motion by Councilman Olson, second by Councilwoman Raffay to close to the public. All members in favor. Motion carried.

The sewage pump station and easement are no longer required or used by the Township and are only useful for the property, and the Township, by this Ordinance, is abandoning the easement and sewage pump station and relinquishing them to the new title of record of the property known as Block 226, Lot 21, 55 Lackawanna Development, LLC, a limited liability company owned by Mr. Gerard Simeone. The Township when it reserved an easement on the property sold the property to Gerard Simeone, pursuant to Ordinance No. 3-2012
