**DISCUSSION ITEMS:**

**Review of Local Board of Health Ordinance** – There was an extensive review of the Board of Health Chapters: 263, 264, 266 & 267. Some suggestions and recommendations were given to update the ordinances.

- Eliminate Chapter 263 and reference the NJ State Statue.
- Chapter 264 – Keep the permit requirements and fee section, then incorporate state code for the rest.
- Chapter 266 – Cindy to look into obtaining a copy of the Public Health Nuisance code of 1953.
- Chapter 267 – Remain as is.

The Board will discuss the revisions further at the January 2015 meeting. For the January meeting the Board of Health members will be reviewing Chapters 272, 274, 277, 283.

**PLANNING BOARD REVIEWS**

The Board of Health reviewed the plans for 19 Meteor Trail. There were discussions as to where the surrounding wells are located in relation to the septic. There was also a question if this residence is a year round or summer.

**NEW BUSINESS:**

Cindy and Ruth had discussed if Septic/Well distance waivers were done in the past. Ruth brought back paperwork showing that about 10 years ago, the county would send out letters to residents advising them to go to the local Board of Health for septic/well distance waivers. Cindy also found minutes to this regard as well.

Scott Olson reported that the owners of Salt Gastropub will be opening their new restaurant “The Trout and the Troll” before Christmas 2014.

Scott Olson, David Gray and Joe Sabatini will be having a meeting with the Sussex County Health Department on December 5, 2014 to discuss procedures.

This was Lois O’Brien’s last meeting. The board members thanked her for her service to the board over the last couple years.
