SUSSEX COUNTY DIVISION OF HEALTH REPORTS:

1. **SWAC** – Bill Koelhoeffer per email stated March meeting was cancelled. He was not present for further comment.
2. **Halulu Hibachi and Sushi** – Email was sent to Byram Township requesting that the facility be inspected. The email was escalated to the county who investigated the complaint. Per Denise Webb from the Sussex BOH, the facility has a Satisfactory status and the county will continue to monitor.
3. **147 Lake Drive**- septic lid was dislodged and corrected. BOH will follow up.

4. **Allamuche Park**- Sussex County BOH received an email complaint of possible chemical waste in the water at Allamuche Park. Results of the investigation confirmed a natural Iron Oxidizing Bacteria condition, not toxic waste. No further action required.
5. **Liquor Factory**- pre-operational inspection required prior to opening.
6. **Sussex County Water Quality PAC**- Don Bogardus requested to be the municipality representative. The request will be given to the township for consideration.

PENDING BUSINESS:

1. Rabies Clinic is scheduled for April 8. Hours 9 to noon. Currently 5 volunteers. Prior prep work was requested to be done on the rabies forms to expedite the process.
2. Community Hours – prior arrangement with a BOH member requested.
