**The applicant acknowledges that hunting is an inherently dangerous activity and occurs in wild unmaintained and uninspected terrain. The Township makes no representations about the suitability of any Municipally Owned property for Hunting and the applicant participates at his own risk.**

**The applicant fully, completely and permanently releases the Township for all liability for hi self or others for all claims of personal injury, death and or property damage.**

**The applicant, his representatives, heirs and estate, agree to defend, indemnify and hold harmless the Township of Byram for any claim from himself or others directly or indirectly relating to hunting activities on Township-owned property. The applicant agrees to provide a defense for the Township and fully reimburse the Township for any costs associated with any claim or lawsuit.**
